WELFARE IS BIG BUSINESS

We see by a supplement to the Mt. Pleasant Times-News (commemorating the dedication of the new County Building in Mt. Pleasant last Friday) that the Welfare Department of Isabella County, or office of the Michi gan Department of Social Services, as it is euphemistically dubbed, occupies more space in the new building than any other department of county government.

We counted at least 23 rooms dedicated to the conduct of welfare business for the county, in the listing of offices in the new building. A "children's play pen" was not counted by us among the welfare office spaces.

Maynard D. Cole, welfare director for the county (it's official ly tabbed Social Services Director) said in a Times-News interview that when the welfare offices opened 10 years ago, beside the river on North Mission Street, that he employed only a staff of four.

"Now," he said in the Times-News interview, "there's a staff

He went on to say, further, as to the many offices in the new building dedicated to welfare, "As it is now, (in the old quarters) I have five workers in one room and it sometimes happens that they have two or three interviews at the same time.... In the new building, my workers will have individual offices for private interviews. And there will be more adequate waiting room."



WEIDMAN'S HISTORY BEGINS LONG BEFORE WEIDMAN CAME

In attempting to lay out an account of the beginnings of the village of Weidman, it is necessary to go back 56 years before John S. Weidman settled on the block of wilderness that is now our village, and built his dam just below the junction of Walker Creek and the Coldwater River.

We have to go back to 1837, when timber barons, already rich from Maine lumber, finished the job in Maine and swooped down on Michigan with its "limitless" stands of giant white pine trees.

The real timber barons were al-

ready rich men before they came to Michigan. Only one gave big money to his adopted town.

We are indebted to Mr. Gordon Fredrickson of Muskegon, father of our own "Bud" Fredrickson of Bud's Store here, for the loan of several copies of the Muskegon Chromicle of last year and this, recounting the great gifts one Charles H. Hackley left to the city of Muskegon.

Hackley, a millionaire several times over, was a Muskegon timber and sawmill man, and was faced with the fact of no natural heirs for his huge fortune. (In those days, several million dol-lars was a huge fortune.)

He gave the City of Muskegon solid and substantial gifts before his death: In 1888 Hackley gave the City of Muskegon \$150,000 for the building of the town's first public library. In 1889 he gave \$15,000 to build a war memorial in Hackley Park and then purchased homes for \$50,000 to clear the land for the park.

When the old Central School burned in 1890, he persuaded the electors to approve a \$75,000 bond issue, then he purchased all the bonds and donated them to the city, the interest from them to support the library.

In 1892 he gave money for the building of a Manual Training Center so that students might learn a trade.

Hackley endowments still contribute money to Hackley Hospital. The hospital was built in 1902, and by then Hackley had contributed \$200,000 and an endowment of \$100,000. He left another \$200,000 in his will and a \$300,000 endowment fund. The

Muskegon Public Schools still receive \$170,000 a year from the Hackley endowments.

Well. That was Charles H. Hackley, a millionaire before he came to Michigan, and who doubled and trebled his wealth, and more in the Michigan woods.
The "big operators" took only.

the perfect, tall white pine. Their lumberjacks swept up the length of Michigan's mitten to the Upper Peninsula and into Wisconsin and Minnesota before they were through. But they wanted only the best of only the white pine.

There were many multi-millionaires, from Muskegon to Bay City and Saginaw, centers for receiving logs from this area in the big-operator days.

There are fascinating huge mansions in both those cities which are lovely today and standing strong, built from choicest lumber by and for the timber barons.

John S. Weidman was not one of these. He was a farm boy in Mecosta County, working on his father's place summers and hiring out in the woods winters.

In his young manhood he began thinking about striking out for himself in the timber business.

He had a little money--it is not clear whether his parents had a certain amount of accumulated wealth, or whether John S. saved his earnings.

He also had those requisites for success in the business world of that time: A natural sense of opportunity within his grasp, and a natural gift of luck. (It has been said that if he flipped coins with other men, his coin would come up as called--and without cheating.)

So that was the background of this area when John S. Weidman came here in 1893 and built his first sawmill on the west bank of a millpond he created by building a wooden dam where the present dam now stands.

He came after the timber barons had cleared this area of choice white pine and moved on. His timber was the left-over lesser pines, the cedars, and finally, the hardwoods.

Others before him made millions of dollars. So far as we've ever heard, John S. made only one million in the town of

Weidman.

He had money enough to build the first sawmill, after having bought up some cheap land (from 50 cents an acre to \$1.50, history books tell us), hire woods-men and sawyers, and begin business.

He had his sawmill, a shingle mill, and a planing mill. The sawmill was close to the road north of the elevator as it stands today; the shingle mill north of that, and a planing mill was located about where the present

lumber yard stands.

The only legacy John S. Weidman left the village named for him was a millpond littered with great stumps of pine and cedar trees he cut to clear the area for the pond.

One thing he did leave us: He left a millpond with dikes built without an engineer, with hand

labor and with stones and earth hauled by men and horses.

Those dikes stand firm and solid today--which is more than we can say for some "fills" put in by a developer who had cut through the old dikes to drain the pond.

John S. Weidman closed the mills here in 1909 and moved to Mt. Pleasant, where he bought the Isabella County Bank, a private financial firm.

We said we'd never again get out the Weidman Messenger on 12 pages, as it is about double the work of getting out our usual eight, and we're not getting any younger.

We have turned down advertising--and we'll do it again--in order to stay on our eight-page

format.

Except for the last issue before a Primary Election. Here we're

caught in a bind. We have printed advertisements for candidates for all sorts of offices for the Primary Election and this week we had a few again. We thought we were all set on eight pages, with a lesser load of political ads than we had last week, when we had to sacrifice pictures for the front page and cram the news in any old way we could.

But on Saturday's mail we received an armload of ads for various candidates for political offices in the Primary Election, and we were obliged to get them in somehow.

We'll see if we can explain with any lucidity the innards of newspaper reason and philosophy.

If we printed just one advertisement for a political candidate in a primary election and refused another, we'd be committing discrimination. Having printed some ads for some candidates in the Primaries, we are obliged to print all that come along within reasonable reach of our advertising deadline.

After the Primaries -- ah, that's a horse of different color.

After the Primaries there will be clear-cut issues and candidates on two parties in Isabella County, and the Messenger will not be obligated to bust a tug to get in all and everybody's ads, if they come in at inopportune times

But in the Primaries--yes. We are obliged, by all newspaper ethics and our own conscience, to tuck in all candidates' ads stating their positions on issues in the Primaries.

After that it's a purely political party battle, and a newspaper may take sides if it wishes. We do not say we shall refuse ads from candidates we don't intend to vote for in the fall elections.

We do say we're not going to go to 12 pages again for the fall elections. We do it now, as we said, for purely ethical reasons in the Primaries.

Incidentally, we notice the little old Weidman Messenger has been gaining recognition right and left this year.

A copy of the Messenger rests with other artifacts in the cornerstone of the new County Building, the first time we have ever been so honored at even lesser functions.

And, since the somewhat celebrated Chippewa Hills school

election, it appears that every regional candidate feels he simply must be in the Weidman paper.

(We just had to mention that, please forgive our audacity.)

We probably couldn't have got out 12 pages this week had it not been for the happy circumstance of two of our sisters, Mildred Garner and Frances Tranbarger, both seasoned newspaper women, offering their considerable help.


