ONE TAXPAYER: NOTHING; TWO THOUSAND--WOW! A lone payer of real estate taxes is a helpless slob.

He may go to his elected officials and complain, and he's treated to a combination of condescension and gobbledegook and deftly eased out the office door.

But a couple thousand real estate taxpayers, mad as hatters, knowing they are the main source of revenue for our various stages of government, especially township, school and county-knowing this, and banding and standing together: brother, will they be heard!

For only the taxpayers (of all descriptions) pour money into the divers and various offices of government and projects emanating therefrom.

Once the real estate taxpayer gets this through his long-suffering head, and once he unites with other real estate taxpayers, he becomes Boss, the guy with the dough.

(And incidentally, some time let's take a good, hard look at Isabella County's 34.4-mill tax rate. That really counts up in tax dollars, if you have any taxable property at all.)

For the past 40 years, Government has behaved as if the tax money is free, it belongs to nobody, and therefore is to be spent as officials see fit and the lowly taxpayer better keep his mouth shut.

If no other result ever showed up from efforts of the Isabella County Taxpayers' Association, there is one result you can count on: All elected officials of every segment of government will realize that the faceless, automatic payer-inner of real estate tax money can gang up together with other faceless real estate taxpayers and become an Organization.

The power of a taxpayers' organization lies in the inherent ability of its members to withhold real estate taxes for three years at any given point.

Judge Robert H. Campbell denied a motion Tuesday morning by the Isabella County Taxpayers' Association to restrain the County Board of Commissioners from making a final payment of \$80,000 to the GEM Surveys, Inc.

The suit, filed Jan. 8, asked the court to prohibit the Board from authorizing the final huge payment of county tax monies to the survey firm on its countywide appraisals of real estate properties.

Judge Campbell said he was not dismissing the Taxpayers' Association's suit, but that it would be left open for any further action which may come up at a later date.

The Judge said that this was not the proper time, based on the complaint filed, for the court to hear the merits of GEM Survey, but that it was the responsibility of the Board of County Commissioners to determine 20¢ per copy Men in Uniform

This was not encouraging to real estate taxpayers, inasmuch as Robert Grinzinger, Isabella County Equalization Director, testified that he had followed GEM's work closely and even had worked with them in the field.

The suit was filed last Friday, asking for a restraining order to prohibit the Board of County Commissioners from making their final payment of \$80,000 to the GEM Survey outfit. The suit was filed by the Isabella County Taxpayers' Association.

Named as defendants were the Isabella County Board of Commissioners, the Isabella County Equalization Department (Robert Grinzinger), and the GEM Surveys.

JUDGE REFUSES INJUNCTION ON GEM PAYMENT

(Continued from Page 1) The Taxpayers' Association also asked that a preliminary injunction be issued by the court restraining the defendants, the Board of Commissioners, from accepting the appraisals as proposed, and from making the final payment to the GEM company; and the defendant Equalization Department from recommending such acceptance and payment, pending completion of an investigation into the GEM Surveys findings, and corrections made.

The Taxpayers' Association also asked the court to make an investigation into allegations of discrepancies in taxable appraisals, and that corrections be ordered to be made where they exist. The Taxpayers' Association also asked that GEM Surveys give an accounting of monies received.

A representative of the Taxpayers' Association said, "We have found what appear to be so many inequities that we feel if they exist, that GEM Surveys should complete its job before it gets paid."

The Taxpayers' Association's representatives contended that, if GEM Surveys were paid for its work, then people who feel they have inequities in their appraisals would have no way of getting satisfaction except what could be received from their local township Boards of Review, meeting in March.

A spokesman for the Taxpayers' Association said GEM Surveys was hired to do a job, and, since the job was not done right, they shouldn't be paid until all possible inequities are investigated.

The suit stated that the Taxpayers' Association had become aware and discovered many gross errors, omissions, discrepancies and variances in the values placed on properties purportedly appraised, including many instances where land value was established without any physical or visual contact by persons establishing the value; many instances where no soil tests, land inspection or other pertinent data was utilized; and many instances where variances of 300 to 400 percent exist as to values placed on similar adjoining properties; many instances where building interiors were not examined although no bar to access existed; many instances of grave errors in judgment and omission of highly pertinent data; and many instances of grave inequities, both individually and collectively.

The suit contended that the errors, omissions, discrepancies and so on, constituted a breach of contract, and that the county board and the county equalization department should have initiated the action of non-payment until an investigation was held.

The suit also stated: "Until

such time as a complete accounting is had and an investigation of all methods utilized and all data collected and analyzed is made, the taxpayers are without recourse as to ascertaining the receipt of sufficient and adequate consideration for monies had and received by GEM Surveys."

At its afternoon meeting, the Board of County Commissioners flatly refused to look at the 400-odd cases of error, inequity and other discrepancies compounded by GEM Surveys. Representatives of the Isabella County Taxpayers' Association attempted to put their proofs before the Board, which refused to give the Taxpayers any of their time.

A committee of the County Board recommended payment of \$80,000 of county tax money to GEM Surveys.

The decision to pay was scheduled by the Board for Wednesday.

A meeting of the Isabella County Taxpayers' Association, county-wide, was scheduled for Wednesday evening at the West Side Elementary School in Mt. Pleasant, beginning at 8 o'clock.

Roger Galer was the only member of the Board to suggest caution and consideration, and as usual was swiftly put down by the Board as a whole.


